1. Regular classes begin Saturday, September 17<sup>th</sup>, 2022 and conclude with year-end recital/examinations, June 2023, date TBA.
2. Placement of students is at the sole discretion of the Artistic Director.
3. When applicable, examination students are chosen at the teacher's discretion.
4. Dancers must wear the appropriate class uniform to all classes.
5. If there is inclement weather and classes are cancelled the studio will advise via email when the makeup class will be.
6. **There will be a service charge of \$25.00 for any cheques returned non-sufficient funds (NSF).**
7. **There is a \$50 deposit per class. Please note – all deposits are non-refundable at any time, except in the case of studio cancellation.**
8. Students are committed to the full school year with their registration as a spot has been reserved in that class for the term. If you wish to discontinue a class or classes at any time, this request must be made in writing via email, to notify All 4 One Dance Company. Non-attendance does not constitute withdrawal from the school. Please refer to the Waiver for additional information and policies.
9. All 4 One Dance Company Inc. may take video footage and still images of your child which may be used in part or in full for publicity purposes and/or promotion with no compensation owed to you or your child.
10. In accordance with Canada's Anti-Spam Law, by signing below you acknowledge and confirm your consent for All 4 One Dance Company to email you directly with information related to our dance school at regular intervals throughout the year.
11. We are committed to protecting your privacy. All 4 One Dance Company, Inc. will store the details submitted on this form. We will NEVER provide your details to any unsolicited third party.
12. We require all dancers to pay their Recital Package Fee in full by November 1<sup>st</sup>, 2022. Recital Package Fees are \$135+HST for the dancer's first class, and \$100+HST for each subsequent class. This fee covers costume, DVD and photos. Deposits towards Recital Package Fees are non-refundable at any time. Recital Package Fees in total are non-refundable after December 30th, 2021.
